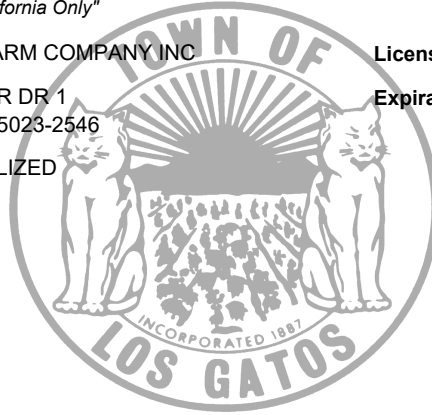

Los Gatos Town Code  
Licenses and Miscellaneous Business Regulations - Chapter 14

Sect. 14.10.100. Posting and Keeping.

All licenses under this chapter shall be kept and posted in the following manner:

Any licensee transacting and carrying on business at a fixed place of business in the Town shall keep the license posted in a conspicuous place upon the premises where such business is carried on. Any licensee transacting and carrying on business, but not operating at a fixed place of business in the Town, shall keep the license in possession at all times while transacting and carrying on such business, or if issued for taxicabs or trucking firms under section 14.20.115, then the license shall be displayed prominently in the vehicle. (Code 1968, 15-19)

Sec. 14.10.095. Term.

A license issued under this chapter shall expire at the end of the year for which the license or renewal is issued unless the license is renewed for an additional period. (Code 1968, 15-18 Ord. No. 2026 XIII, 2-18-97)

Sec.14.10.020. Required-Generally.It shall be unlawful for any person to transact and carry on any business, trade, profession, calling or occupation in the Town without first having procured a license from the Town. (Code 1968, 15-3; Ord. No. 1929, II, 1-19-93)

Sec.14.10.015. Articles I through III of chapter for revenue purposes.Articles I through III of this chapter are enacted solely to raise revenue for Municipal purposes, and are not intended for regulation. (Code 1968,15-2)
