#### SEPARATE BUSINESS LOCATIONS

In accordance with the section 5.04.120 of the City's Municipal Code, a separate license must be obtained for each branch establishment or location of the business transacted and carried on and for each separate unrelated type of business at the same location, and each license shall authorize the licensee to transact and carry on only the business licensed thereby at the location or in the manner designated in such license; provided, that warehouses and distributing plants used in connection with and incidental to a business license under the provision of this chapter shall not be deemed to be a separate place of business or branch establishment.

### LICENSE REQUIREMENT FOR CONTRACTORS THAT WORK FOR YOUR BUSINESS

In accordance with section 5.04.270 of the City's Municipal Code, if you have anyone working for you in Morgan Hill that you are not claiming as an employee (for example a dance instructor or a cosmetologist at a salon), and you issue them a 1099 tax form, they must have their own business tax certificate in the City of Morgan Hill. Their tax certificate must be posted when they are doing business.
